Please make sure you send 2 copies of your insurance document with your photo and joining form, failure to do so will prevent you from using the launch facilities of the club until we have this on our records.

Any attempt by a member to use the facilities with out this document in place, will result in the committee being forced to take action against any said member, this will include the revoking of a members membership.

Prestatyn Sailing Club Skippers Duty of Care

PSC

Safety Equipment is required on all vessels at all times and is the responsibility of the skipper/owner to check that this is in place:

- 1 Life Jackets meeting British Standard Specification for each person on board or Buoyancy Aids to SSBNF approval
- 2 Suitable Anchor attached to a chain
- 3 Flares, hand held type. At least 2 of which must be within the expiry date shown. Mini flares are acceptable, but Prestatyn Sailing Club strongly advise that hand held type are available on the vessel.
- 4 Compass – fixed or hand held
- 5 Bailer – if not equipped with a self bailer
- 6 Fire extinguisher – Power Boats
- 7 Vhf Radio fixed/handheld or Mobile Phone must be carried
- 8 No vessel shall be launched or be used from the Prestatyn Sailing Club launch facilities unless there is in force, in relation to the vessel, an Insurance Policy covering third party risks,
Either unlimited in amount, or with a limit not less than fixed per accident by the major marine insurance companies

The Skippers Duty of Care: Skippers must be aware that they are fully responsible for the safety of themselves, their crew, property and vessel at all times.

It is to be hoped that the above information will clear any grey areas surrounding the minimum requirements of the club.

Ultimately it's the user's responsibility to bring their vessel up to this minimum standard each time they go to sea.

The Club has set these as its minimum safety requirement for all boats wishing to use the clubs facilities.

I, as the member/owner of said vessel agree to the above terms and conditions and confirm that all items listed are present and correct.

Important

All watercraft, trailers or member vehicles are launched or parked entirely at owners risk, with no blame in the event of damage, howsoever caused, being attached to tractor drivers or club members.
